Introduction

Dear Humboldt County residents and community,

Our mission at Humboldt County Public Health is healthy people in healthy communities. This includes our efforts to improve the health of the public by using science-based evidence backed strategies to give everyone a safe place to live, learn, work, and play.

In Iowa, all 99 counties are represented by a public health agency. A recent review of all counties concluded that there are 8 different ways a public health department is structured in Iowa. We follow a hospital based agency structure as a department of Humboldt County Memorial Hospital. We have found this structure provides the best support for our county as the collaboration between public health, hospital and primary care clinic is imperative for coordination of care for you and your families.

Humboldt County Public Health Board is comprised of a five community member advisory board which meet to review and access the progress and needs of our community. The activities in which our public health agency operates all fall within the 10 Essential Services of Public Health as recommended by the Center for Disease Control and Prevention.

We recognize that there are many factors that influence a communities health and hope that the information contained in the 2023 Community Health Assessment provides a useful synopsis of the health status of our community and increases the understanding of a healthy community.

We look forward to working with our community and partners to address the health issues outlined here as we work to create our Humboldt County Health Improvement Plan.

As part of this Community Health Assessment we carried out a survey among our community members, partners, and staff. Along with the survey, secondary data from various local, state, and national resources are highlighted.

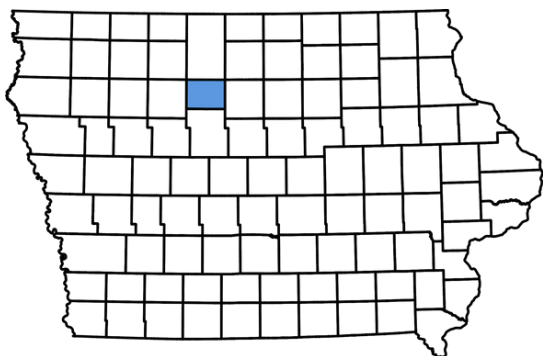

Population Trends

Humboldt County is home to an estimated 9,572 individuals, with nearly half of those individuals residing in the city of Humboldt. The county continues to see a slight decrease in population from 2020 to 2022, but a ten-year decrease of (-2.22). All Humboldt's neighboring counties have seen decreasing population while the state of Iowa has seen a ten-year increase in population by 4.73%

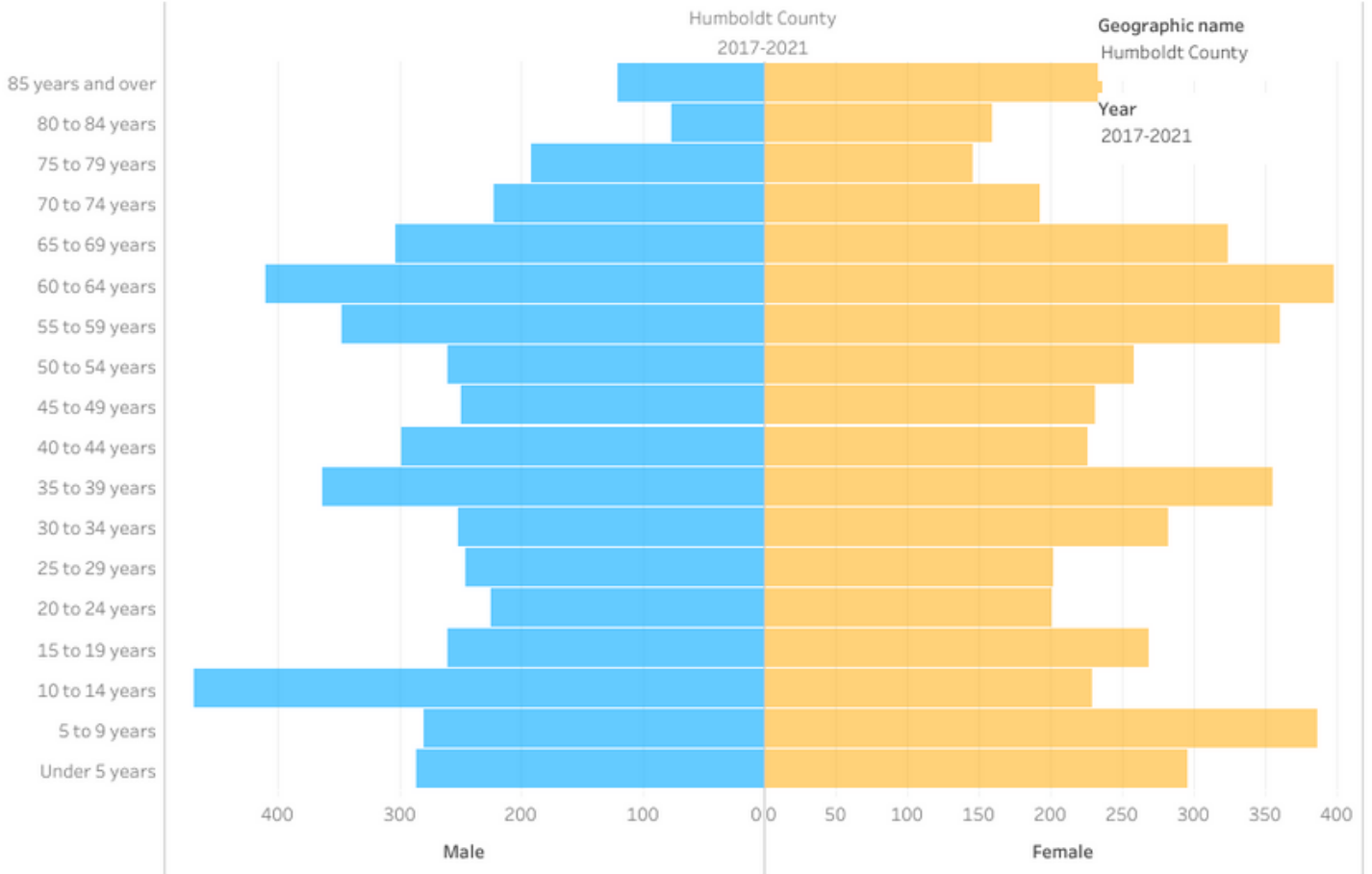
While Humboldt County is predominantly white (92.9%), we have seen a minor decrease in the population that is white from 2010 to 2020.

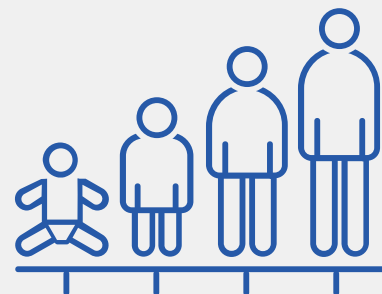

Age

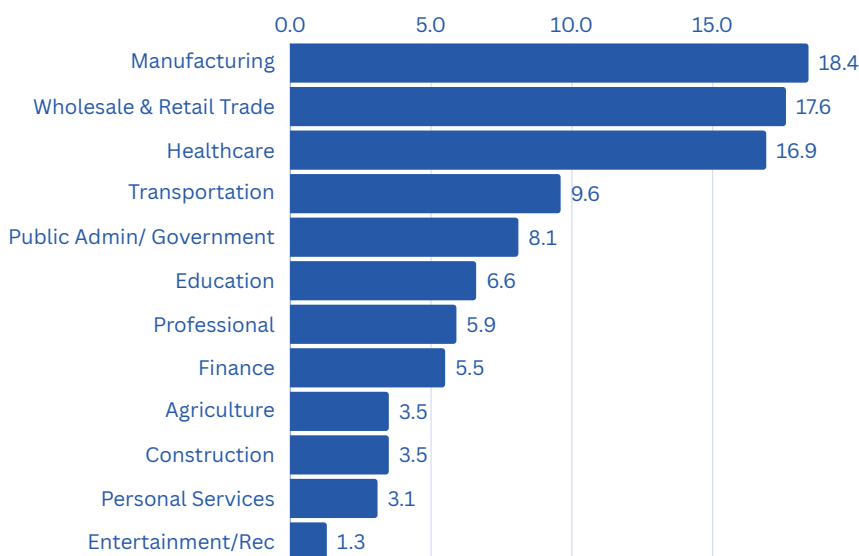
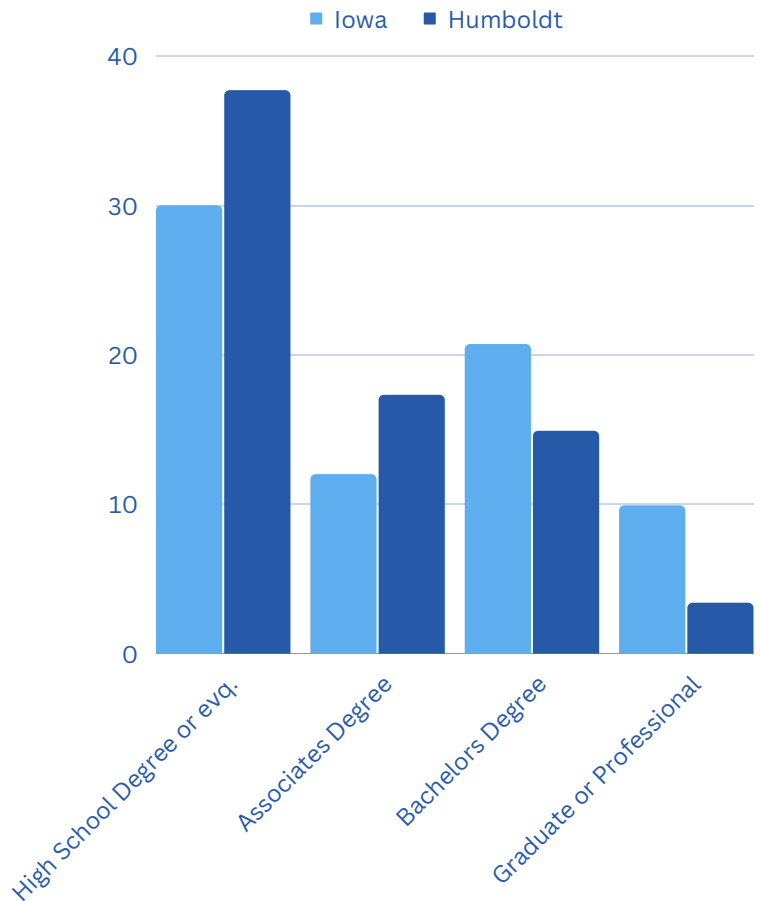
Education

Humboldt Community School District continues to grow on its vision of learning and success for all. Humboldt High School is ranked 26th out of all of the Iowa high schools according to the most recent US News Rankings. Humboldt schools have a graduation rate of 93%.

Math and Reading Proficiency

82% of students tested at or above the proficient level for reading, and 83% tested at or above that level for math.

Humboldt County is served by the Humboldt Community School District which serves approximately **1,500** students yearly.



Employment

The Humboldt County workforce is made up of a wide variety of industries. Those among the top industries of employed Humboldt residents include: manufacturing, wholesale/retail trade, and healthcare. Humboldt has approximately 35.5% of residents that work in other communities. Most of those who are out commuting are to Fort Dodge or Pocahontas.

Economic Stability can be described as the ability to access resources that are essential to one's life and well being. Within Humboldt County we experience an **unemployment rate of 2.5%** in our population. Other key areas that impact economic stability are highlighted below.

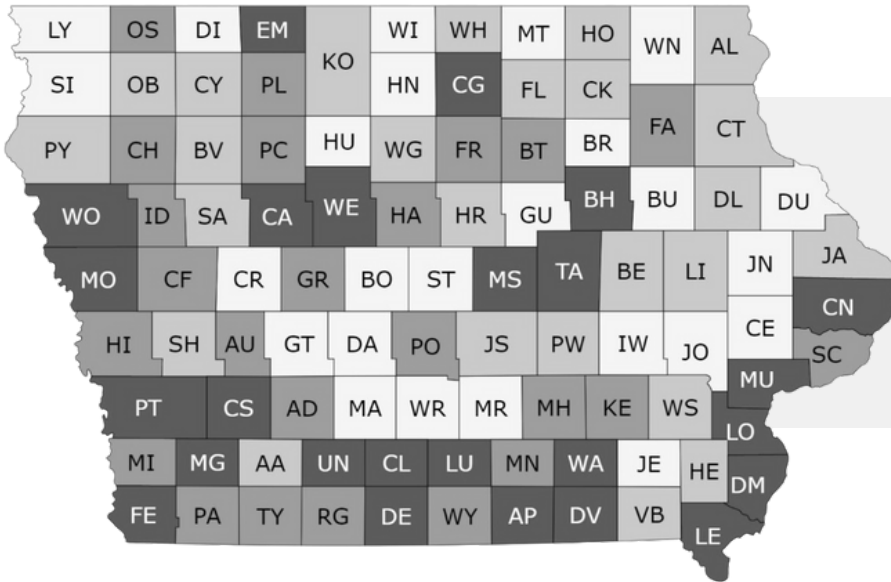

Economic stability and its contributing factors impact the health and well-being of individuals. Daily struggles around unemployment, poverty, housing instability and food insecurity all contribute to an increased risk of poor health outcomes for people.

County Health Rankings

Humboldt is ranked the **20th** healthiest county in the state of Iowa in **health outcomes** in the 2023 County Health Rankings report. Health outcomes include length of life and quality of life. It is a measure of how healthy a county is **right now**. The ranking reflects the physical and mental well-being of residents.



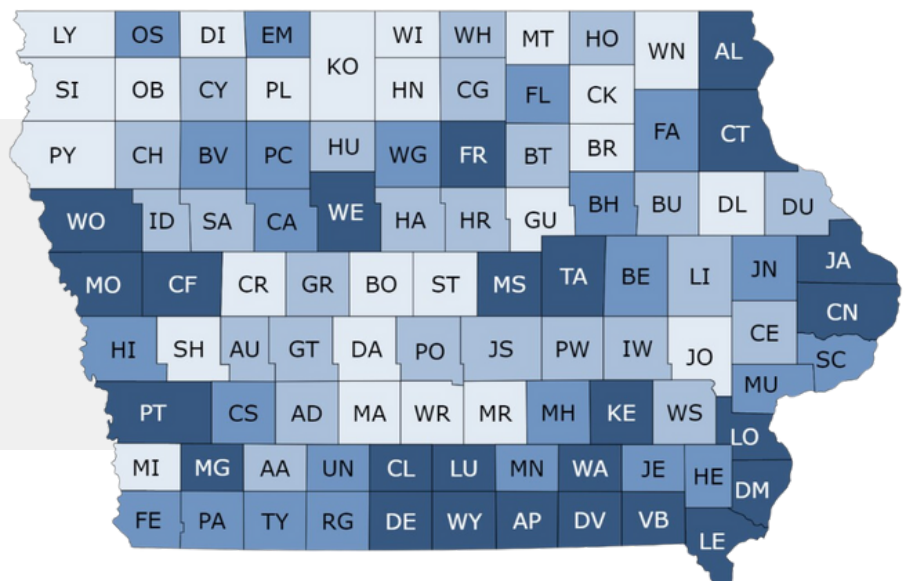

Health Factors

County Health Rankings Health Factors represent community conditions that we can change to improve health and opportunity, such as access to **quality education, living wage jobs, quality clinical care, nutritious foods, green spaces, and secure and affordable housing**. Chronic diseases are defined broadly as conditions that last 1 year or more and require ongoing medical attention or limit activities of daily living or both.

Diabetes

8.4% residents 18+ have a diabetes diagnosis

Residents who have been told by a provider that they may have prediabetes has nearly **TRIPLED** in recent years.



Heart Disease and Stroke

#1 cause of death in Humboldt County

High blood pressure, high blood cholesterol, and smoking are key risk factors for heart disease. Other factors include: diabetes, obesity, diet, inactivity, and alcohol use.



Chronic Lung Disease

Chronic Obstructive Pulmonary Disease (COPD) is among the nation's most common and costly chronic conditions. COPD refers to a group of diseases that cause airflow blockage and breathing related problems.

Community Input Survey Overview

In the summer of 2023 Humboldt County Public Health in collaboration with Humboldt County Memorial Hospital surveyed the members of the community.

Feedback was solicited using an online survey tool that was easily accessible via a link or QR code. Postcards like the one to the right were distributed at local events that Humboldt County Public Health was participating or volunteering with.

We also utilized the power of social media marketing to share on different social platforms to increase our reach within the community.

Other partners essential to the collection of survey results were the Humboldt Community School District which helped share the link and information with teachers, parents and students. And our Humboldt County Economic Development Association was able to share with all Humboldt County businesses and their employees.

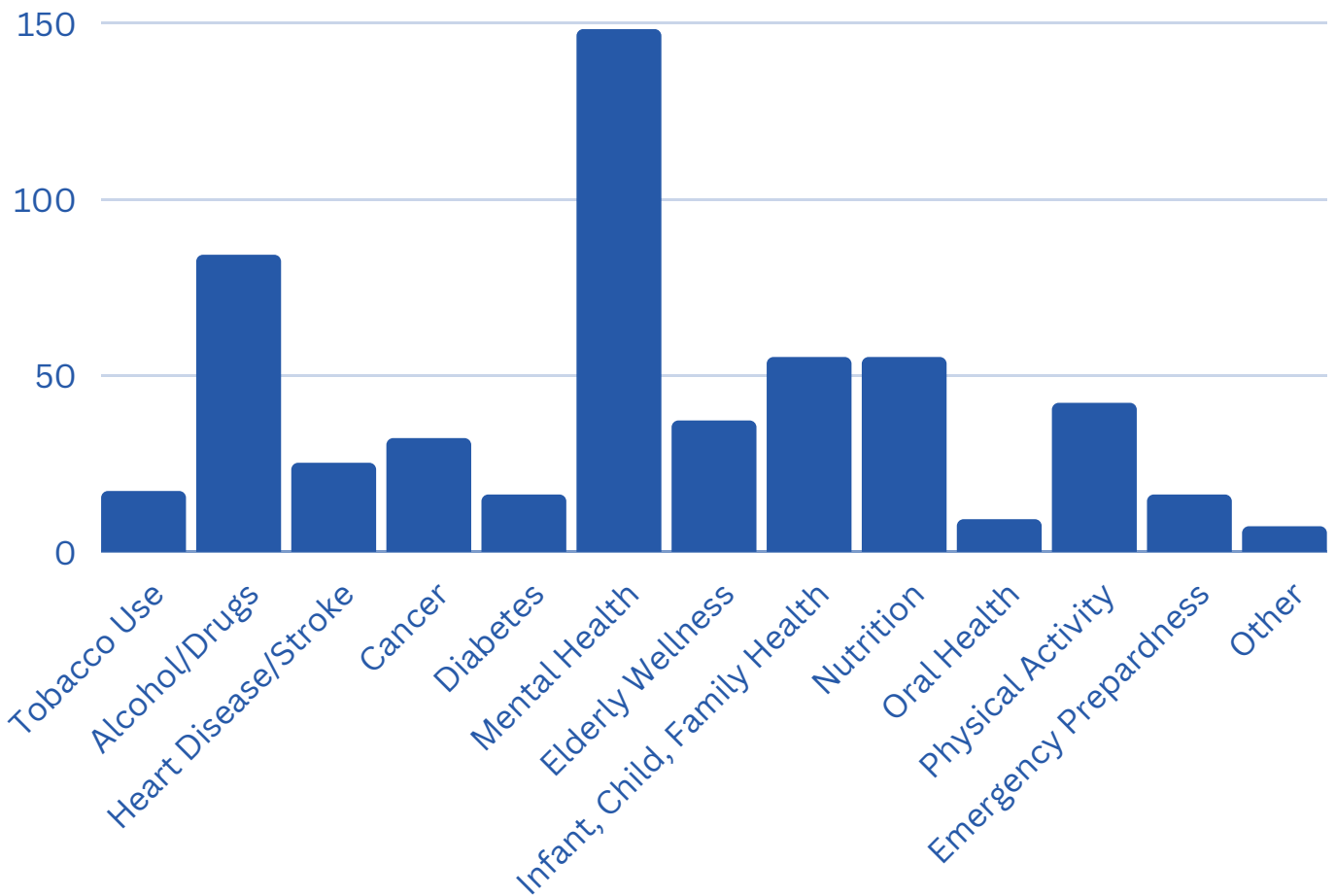
The survey was open from March 5- July 5. At the close of the survey we had nearly 200 individuals who had participated.

A review of the survey data was presented at the Board of Health meeting with the approval to move forward with the process in identifying strategic priorities and planning process.

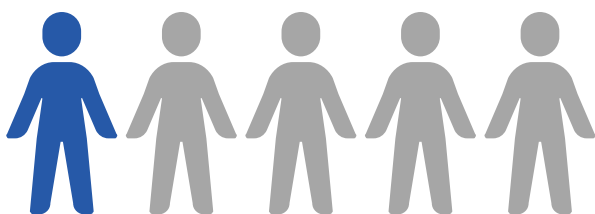

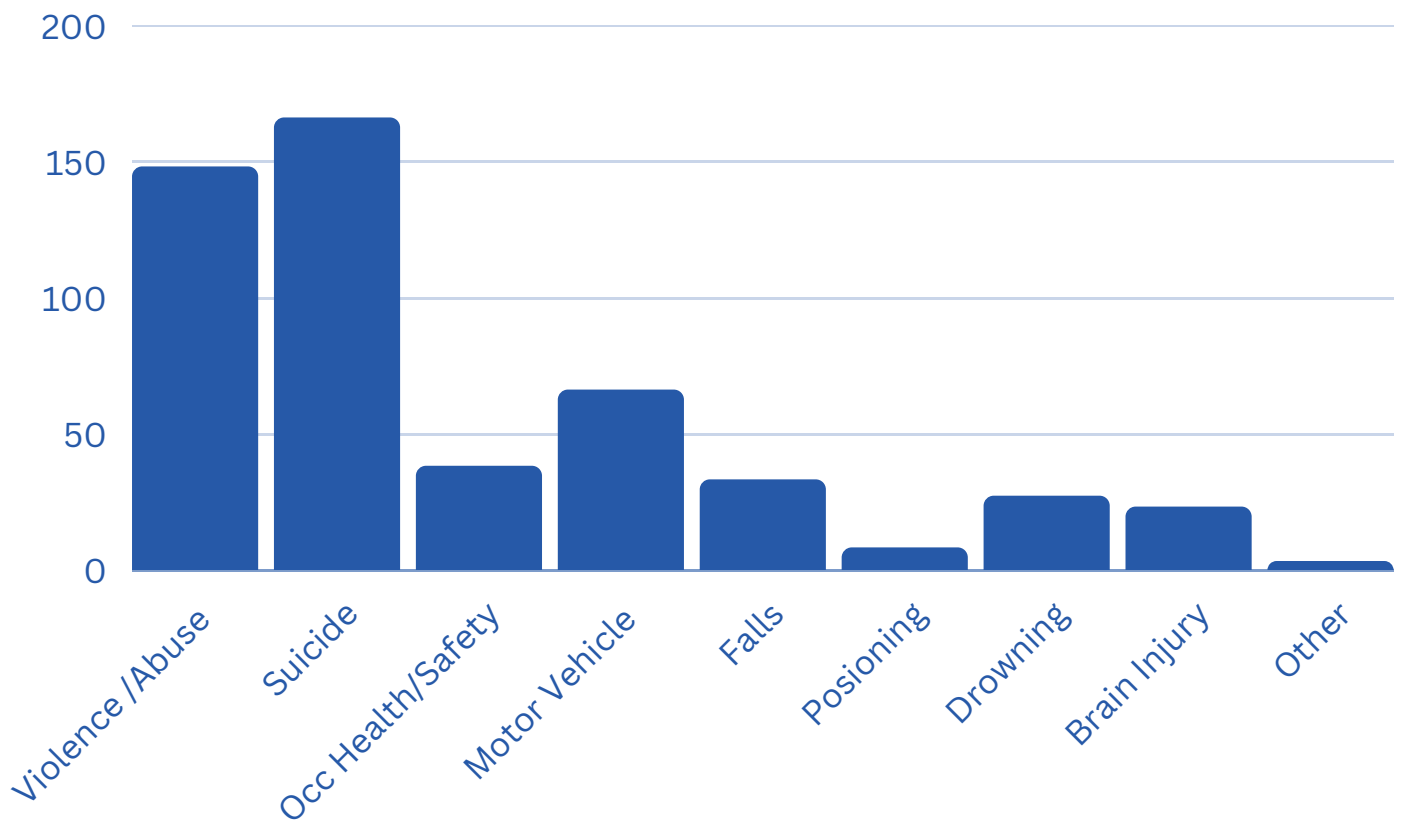

Violence is a widespread public health priority that impacts all of us and can occur in many forms:

- Child abuse and neglect
- Child sexual abuse
- Youth violence
- Sexual violence
- Intimate partner violence
- Elder abuse
- Homicide
- Suicide

Many individuals who survive violent experiences are left struggling with long-term physical, psychological, and emotional effects. Violence can erode entire families and communities by reducing productivity, decreasing property values, disrupting essential social services, and making people feel unsafe in the places they live, work, and learn.

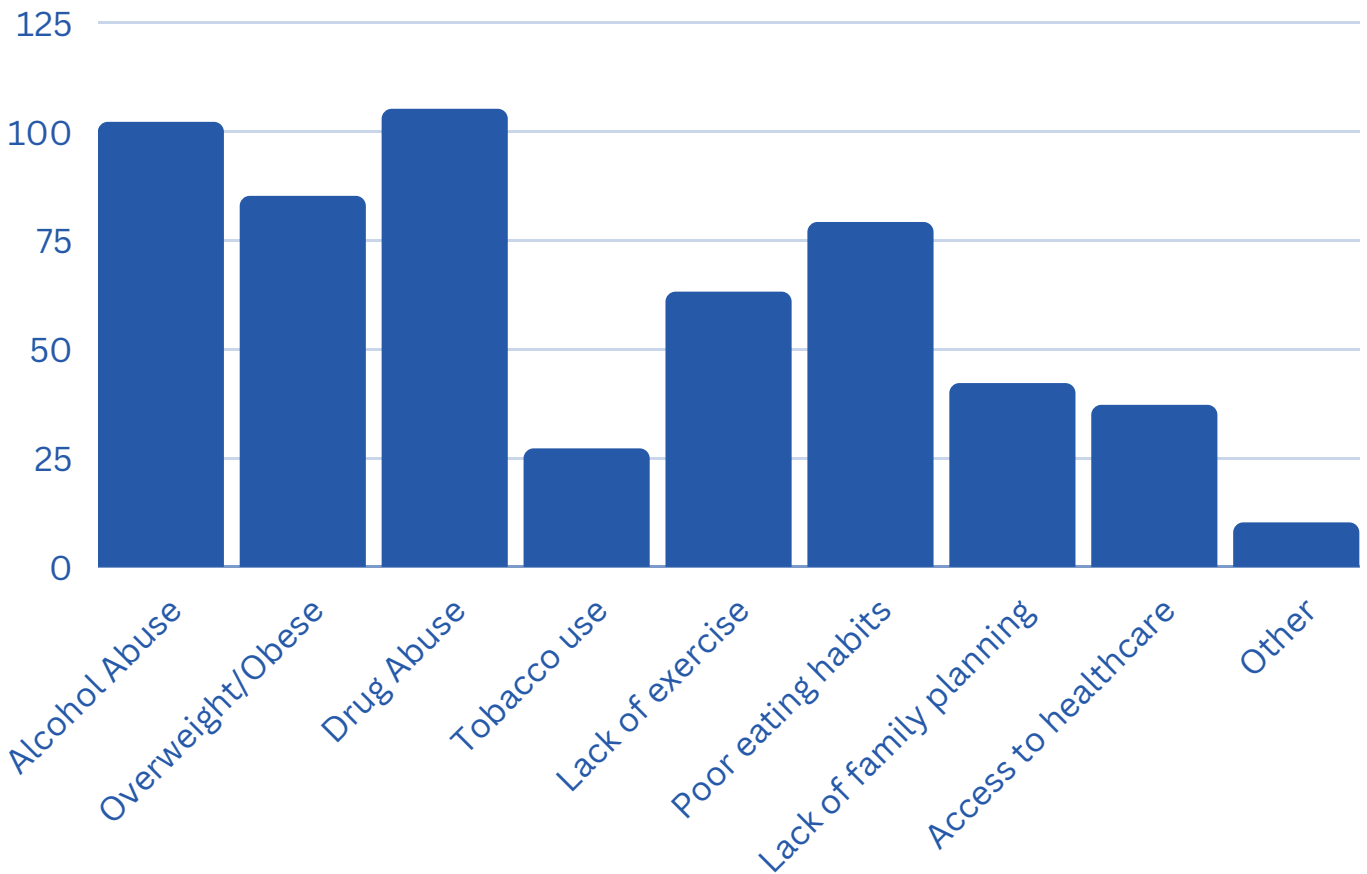

What behaviors have the greatest impact on community health?



Health behaviors are practices that can either improve or damage the health of the individuals or community members. Health behaviors are determined by the choices available in the places in which our community lives, learns, works, and play.

Most Iowans are participating in some physical activity; however, only about one-fifth are meeting the recommended guidelines for physical activity.

Physical Activity Guidelines for Adults

- At least 150 minutes of aerobic physical activity per week
- Muscle strengthening activities on 2 or more days per week.
